We will be selling jams and jam biscuits to fundraise for our charity, for which the funds will be entirely reinvested into the Enactus Society project that donate meals for homeless people at partner homeless shelters, soup kitchens, and community cafes. All volunteers who will make the items or run the stall have completed their food hygiene level 2 or will be supervised by someone who has completed this training. Payments will be taken by Sumup Card Machine. No Cash will be accepted at this event.</p> <p style="color: red;">We will label each jar with a full list of ingredients, and a use-by date which includes a "Once opened, consume within 3 days".</p> <p style="color: red;">Food safety procedures:                  We will use jam jars that haven't been used                  We will make sure the jars don't have any chips or cracks                  We will make sure they have tight-fitting lids that have been sterilised</p> <p style="color: red;">The jam biscuits will also have a clearly visible sign at the stall stating all ingredients used and the possible presence of allergens.</p> <p style="color: red;">Southampton Enactus takes responsibility of the general running of the event. Preparation of how we make and sell the goods and ensuring all health and safety in this assessment is followed. SUSU takes responsibility for supplying the sites and facilities needed to run the event including venue space, Chairs and tables. On the day it will be expected that committee fulfil their pre-agreed roles and duties assigned by the event lead. ### Risk process

1. Identify the impact and likelihood using the tables above.
2. Identify the risk rating by multiplying the Impact by the likelihood using the coloured matrix.
3. If the risk is amber or red – identify control measures to reduce the risk to as low as is reasonably practicable.
4. If the residual risk is green, additional controls are not necessary.
5. If the residual risk is amber the activity can continue but you must identify and implement further controls to reduce the risk to as low as reasonably practicable.
6. If the residual risk is red do not continue with the activity until additional controls have been implemented and the risk is reduced.
7. Control measures should follow the risk hierarchy, where appropriate as per the pyramid above.
8. The cost of implementing control measures can be taken into account but should be proportional to the risk i.e. a control to reduce low risk may not need to be carried out if the cost is high but a control to manage high risk means that even at high cost the control would be necessary.
